- I didn't realise that returned soldiers couldn't transmit their homes to their descendants.
- These examples make me sad and mad, however, they have been presented in a way that I think I can share with others and they might get a better understanding
- A lot of governance and systems are impenetrably white
- In addition to the National Climate Risk Assessment report, there is the Climate Risks to Aboriginal and Torres Strait Islander Peoples Report

- On a tangent, in Aotearoa NZ we have 1000s of visitors from Australia, many of them in
  places highly vulnerable to natural hazards (e.g., skiers in Queenstown, trampers on the
  West Coast). As Maori we have systems we roll out in any event but a major seismic event
  could isolate 100s of Australians. At some point we should connect Maori and First Peoples
  EM operators to help coordinate in a response.

  of Indigenous Disaster Resilience and the need to change the way we work with First Nations
  People. Your strength, resilience and determination for Mob is amazing. Thanks you
