The Handbook Collection:         <ul> <li>is the authoritative and trusted source of knowledge about disaster resilience principles in Australia</li> <li>aligns national disaster resilience strategy and policy with practice, by guiding and supporting jurisdictions, agencies and other organisations and individuals in their implementation and adoption</li> <li>highlights and promotes the adoption of good practice in building disaster resilience in Australia</li> <li>builds interoperability between jurisdictions, agencies, businesses and communities by promoting use of a common language and coordinated, nationally agreed principles.</li> </ul> </li> </ul>
	Australian Emergency Management Arrangements (Handbook 9) has been scheduled for review.
Purpose	The purpose of the Australian Emergency Management Arrangements Handbook ('the handbook') is to:  • be the authoritative and trusted source of knowledge of the emergency management arrangements in Australia
	<ul> <li>provide clarity on the nationally agreed principles regarding emergency management arrangements in Australia</li> </ul>
	<ul> <li>identify and promote the adoption of good practice in emergency management arrangements</li> </ul>
	<ul> <li>build interoperability between jurisdictions, agencies, businesses and community leaders by outlining common language and coordinated, nationally agreed principles;</li> </ul>
	<ul> <li>align national disaster resilience strategy and policy with emergency management arrangements by informing and assisting jurisdictions, agencies and other organisations and individuals in the implementation and adoption of these arrangements.</li> </ul>
	As the handbook reflects nationally agreed principles, its primary purpose is not to guide emergency management in a response to a disaster. However, this does not rule out the potential support the handbook may provide in this environment. Where need and value are demonstrated, companion tools will be identified and developed to provide additional guidance and support to the handbook in these circumstances.
Audience	The intended audiences for the handbook are the people responsible for developing policies, capabilities and doctrine within their own jurisdictions, agencies, organisations, and communities. These agencies and organisations include Commonwealth, state, territory and

	local government departments, emergency management agencies and non-government organisations.
	The audience may also include community groups, educators, researchers, planners, businesses and the private sector that may also find content in the handbooks that will be of value to them.
	It is expected that international organisations involved in emergency management will also use the handbooks.
Project Description	The project will draw on and complement current and ongoing activity in emergency management arrangements and build on the capability and knowledge of organisations and individuals across the disaster resilience sector in Australia and internationally.
	A multidisciplinary expert reference group will inform the project and a content writer engaged.
Outputs	A project brief and project plan.

	3. Environmental scan including needs assessment and gap analysis to inform handbook content and to reflect current good practice in emergency management arrangements.

A published Emergency Management Arrangements handbook that will:</li> <li>be published online with read, print, search and purchase functionality through the Australian Disaster Resilience Knowledge Hub and other AIDR websites.</li> <li>be governed by a set of principles and guidelines to ensure compliance with the Australian Disaster Resilience handbook collection framework, policy and guidelines.</li> <li>include a process for lifecycle management of the handbook.</li> <li>include a framework for identifying and developing resources to support adoption and application of the handbook in practice.</li> </ul>
	<ol> <li>National promotion of the Australian Emergency Management Arrangements handbook.</li> </ol>
Outcomes	The Australian Emergency Management Arrangements handbook will be developed with current and relevant content that will be easily accessible and useful for anyone involved in or interested in emergency management.
	The handbook will be recognised as a leading authoritative guidance in emergency management arrangements in Australia. It will be well-known and be referenced and form the foundation for development of more detailed, jurisdictional and agency relevant emergency management arrangements.
	The project will increase general awareness of good practice principles in emergency management arrangements.
